

**COPYING, TRANSFERRING OR RE-RECORDING OF SOUND IDEAS PRODUCTS
RIGHTS AND LIMITATIONS:**

Your purchase of any Sound Ideas product (CD, DVD, Track or Hard Drive) grants you a lifetime non-transferable license for synchronization rights only and in addition permits you to create a working copy of the sound(s) to be stored on the storage medium of your choice, such as a computer server or hard drive. The sounds (and the copies) are to be used only for the authorized purposes as defined in Sound Ideas End User License Agreement. If the sounds are going to be accessed by more than one (1) workstation, a multi-user annual site license must be sought by the user. Sound Ideas provides a free multi-user site license with every Hard Drive purchase (and on user request) that permits access by up to five (5) workstations located Onsite. If the sounds will be accessed by more than five (5) workstations located Onsite, or if the sounds will be accessed from Remote Locations, an annual license fee will be charged as per the Definitions and Schedules below.

Sound Ideas Multi User Annual Site License: *Options and Fee Schedule*

DEFINITIONS

For the purposes of interpreting which fee structure applies, please use the following definitions.

- Hub Site:** The primary location or postal address of the Licensee, at which the hard disk or other storage medium is housed.
- Onsite:** The same postal address as the Hub Site.
- Remote Site:** A different postal address than the Hub Site.

OPTION 1

ONSITE LICENSE

- All workstations are housed within the same address as the Hub Location. All workstations accessing the network must be doing work that is directly related to the main business being conducted by Licensee.

BASIC CONDITIONS:

- The Hub Site must either own physical copies of all the Sound Ideas products that are to be copied to hard disk or must have purchased the products on Hard Drive from Sound Ideas or one of its licensed distributors
- The Hub Site is entitled to up to 5 onsite workstations with no license or fee required
- No Remote Sites may have access to Sound Ideas products or sounds

LICENSE FEE:

- the annual license fee for first five (5) workstations is included with the purchase of Sound Ideas products**
- \$100 annual fee for each additional group of 5 workstations or less, up to a maximum of 25 workstations**
- annual fee for more than 25 workstations – price upon request**

OPTION 2

REMOTE ACCESS LICENSE

- Not all workstations are housed within the same address as the Hub Site. All workstations accessing the network must be doing work that is directly related to the main business being conducted by Licensee.

BASIC CONDITIONS:

- The Hub Site must either own physical copies of all the Sound Ideas products that are to be copied to hard disk or must have purchased the products on Hard Drive from Sound Ideas or one of its licensed distributors
- The Hub Site is entitled to up to 5 onsite workstations with no additional fee required
- The Hub Site is entitled to access by up to 2 Remote Sites with no additional fee required
- Each Remote Site is entitled to up to 5 onsite workstations with no additional fee required

LICENSE FEE:

- \$1,000 annual fee**

FEES FOR ADDITIONAL REMOTE SITES:

- For each additional Remote Site (in excess of the 2 Remote Sites that are permitted under Basic Conditions as stated above)
 - \$500 annual fee per additional site**

FEES FOR ADDITIONAL WORKSTATIONS: HUB OR REMOTE SITES

- \$100 annual fee for each additional group of 5 workstations or less, up to a maximum of 25 workstations**
- annual fee for more than 25 workstations – price upon request**

STATEMENT OF INTENT:

Immediately upon any return, assignment, transfer or sale of any Sound Ideas proprietary sounds or music products or sounds or music products represented by Sound Ideas (all hereby referred to as "Sounds") all such Sounds that are contained on any computers, hard drives or discs or other electronic storage medium must be deleted immediately. Computers, hard drives or discs or other electronic storage media containing Sounds cannot be sold, given away or otherwise disposed of unless or until all the Sounds have been deleted. Copyright infringement is a serious offence. Sound Ideas protects its copyright by all necessary means, including legal action. A valid Multi User Annual Site License, issued directly by Sound Ideas is required to authorize remote access to any Sound Ideas royalty free product regardless of whether or not an actual fee is stipulated under this fee schedule.
